Position Description

Providing instrumental music tutoring to students within the Music Co-curricular Program of the College, the Music Tutor needs to appreciate and embrace all aspects of College philosophy, pastoral care and general student management and wellbeing.

This position is accountable to the Head of Music and is responsible for the management and development of the music program working collaboratively with all key members of the Music Department.

This position may be required from time to time to assist, with wider rehearsals and school events such as the Annual Music and Chamber Concerts, Jazz Night, and Liturgical events.

Responsibilities

- To enhance a student's solo performance ability through appropriate performance and practice techniques.
- To develop literacy, aural and theoretical skills appropriate to the student's instrument and standard, aligned with their classroom music curriculum where appropriate.
- To develop in students a knowledge of a broad range of musical styles and techniques, which may include improvisation.
- To assist students in their participation in a current school ensemble
- To support the Music Program when required in the preparation, maintenance, and rehearsal of ensemble material pertinent to those instruments taught.
- To prepare students for at least one graded examination through a recognised body external to the school, e.g. AMEB, ANZAC where agreed upon with the Music Leaders (Ensembles/Voice)
- To keep an attendance roll for each of student
- Complete Semester reports by specified dates prepared to appropriate school guidelines.
- On request, check school instrument and inform the Music Administrator of any necessary repairs
- Promptly report to the Music Administrator any repairs needed for a school instrument that is loaned to a student
- To attend, in consultation with the Head of Music, functions outside of school hours, e.g. School Concerts, Music Camp, Festivals or Mass
- To attend all scheduled meetings called for Instrumental Music Staff as well as general staff meetings if required,
