KEY OBJECTIVE OF THE SERVICE/DEPARTMENT:

The NDIS Partners in the Community Program (PITC) supports the National Disability Insurance Scheme (NDIS) to be implemented at a local level.

As a partner of the NDIA, Northcott will deliver the NDIS Early Childhood Approach to local communities in Northern NSW, Mid North Coast, Hunter New England, North Sydney and Western Sydney.

The approach supports the Early Childhood activities that will improve independence and social participation of children with disability, developmental delay or developmental concerns aged 0-9 years.

The early supports team provide therapy services that aim to build family capacity in the child's natural environments. Therapy services may be provided in individual or group settings and utilize coaching models to upskill parents and caregivers to support their child's developmental needs.

KEY OBJECTIVE OF THE POSITION:

- Provide timely, evidence based and person centered therapy services to families and children with developmental concerns in individual and group settings.
- Work with a pediatric caseload to achieve the best outcomes for families and their children.
- Ensure children and families are supported using a child and family centered approach to shape the most effective supports they require, based on detailed consideration of the evidence and best practice in early childhood.
- Support families to establish short-term therapy goals that work toward improved participation in every day routines.
- Work with families to determine the supports and connections they require to achieve their individualized goals within a timeframe of 3-6 months.
- Mentor and support a multi-disciplinary team of EC Coordinators to deliver best practice Early Childhood therapy that will enable children and families to achieve improved independence, social participation, and quality of life.
- Provide referrals and linkages to community and mainstream supports that will build social engagement and support families of children with disability, developmental delay, or developmental concerns.

- 1. Working with a pediatric caseload of children aged 0-9 and their families to achieve the best possible outcomes through short term therapy.
- 2. Lead training, support and clinical supervision to a multi-disciplinary team delivering a key worker approach to children with developmental concerns and delays.
- 3. Engage with families to gather information through methods that align with National Best Practice Guidelines for Early Childhood Intervention to complete a family centered plan.
- 4. Support families to establish meaningful goals & aspirations for their child and family and track progression toward goals using outcome measurement tools.
- 5. Lead the delivery of workshops and groups to provide families and external stakeholders with information to support children with developmental delays or concerns.
- 6. Assess and review the progress of the child and family against originally defined goals.
- 7. Provide recommendations based on clinical knowledge, professional judgement and information gathered that are most appropriate to the improvement of the child's development and social participation.
- 8. Share discipline specific knowledge and support in alignment with the transdisciplinary approach.
- 9. Implement group therapy programs in line with evidence based and best practice early childhood models.
- 10. Develops and coordinates quality improvement initiatives in team / discipline informed by best practice standards.
- 11. Perform and review functional assessments on children including the PEDI-CAT & ASQ-3.
- 12. Attend, present and participate in internal and external professional development activities.
- 13. Establish and maintain effective relationships with local and regional stakeholders, including Early Childhood Education settings, mainstream and community services providing information and support to children with disability and developmental delay.
- 14. Adhere to the strict response timeframes as required in the PITC EC Statement of Requirements, Standard Operating Procedures and Grant Agreement.
- 15. Be aware of, demonstrate a commitment to and actively work toward the performance measures of the EC program outcomes as stated in the NDIS Outcomes Assurance Framework and PITC EC Statement of Requirements.
- 16. Ensure that record keeping, data entry & achievement of KPIs is consistent & timely.
- 17. Work within a strengths based, family centered approach that provides support families to build capacity, problem solve and resolve issues as identified.
- 18. Be aware of and sensitive to the needs of children, families and communities from Aboriginal and Torres Strait Islander or Culturally and Linguistically Diverse backgrounds.
- 19. Work within the framework of the, Best Practice Guidelines in Early Intervention, NSW Disability Inclusion Act, National Disability Standards, Privacy Legislation, NDIS Act 2013, NDIS Operational Guidelines and other relevant legislation.
