This role is responsible for leading the effective, ethical, and sustainable sourcing of goods and services that maximise value for money, ensure supply continuity, and enhances long-term cost and service benefits for the organisation.

	selection.
	 Identify inefficient and unproductive contracts and develop expedited exit strategies ensuring minimal loss.
	 Prioritise requirements and spend to aggregate demand including organisation
	wide standards across all spend categories.
	 Maintain accurate reporting on category portfolios, delivery of business planning and price forecast activities.

	including variances on a routine basis.

CAPABILITIES	 Ability to anticipate market trends, think long-term and align sourcing to organisational strategy. Proven leadership and ability to manage stakeholders, build strong partnerships and influence at all levels. Strong commercial judgment and strategic decision-making in high-risk, high-reward environments. Advanced negotiation skills, able to manage strategic supplier engagements and extract long-term value.
SKILLS & QUALIFICATIONS	 Tertiary qualification in the relevant discipline (i.e. Business, Commerce, Law, Procurement & Supply Chain etc). Demonstrated knowledge of ethical and sustainable procurement practices, particularly related to social procurement and supplier diversity initiatives. Excellent written and verbal communication skills to ensure clear and concise information is presented to stakeholders and strong working relationships are maintained. Highly adaptable and flexible with the ability to adjust quickly to new situations and changing priorities. High-level data-analysis and cost-benefit analysis knowledge is desirable. Effective written and verbal communication and presentation skills. High-level problem solving, data analysis, and solution development skills. Strong technology literacy (e.g. MS Excel, Word, PowerPoint).
EXPERIENCE	 Minimum 10 years demonstrated experience in procurement and experience in leading and demonstrating sustained cost savings initiative. Proven experience as Head of Procurement or similar. Demonstrated experience in leading complex, high-value sourcing projects. Experience building and developing high-performing procurement teams.
