## **Position Summary**

The Director of Rowing is responsible to effectively and safely lead the Senior School rowing program. The role ensures the development of a high performing and inclusive program that fosters student growth, wellbeing and achievement.

The Director of Rowing has delegated responsibility for the efficient operation and team leadership of sport including staff management, competition planning, safety, compliance and community engagement. Teachers-in-Charge of sporting programs, through a greater understanding of the staff and students involved in the sport, will assist with the development of skills and abilities of both groups, develop crew camaraderie and ensure growth and development that will put them at the service of others in a community.

The Director of Rowing is a prominent leadership role within the School and the wider Victorian rowing community. Trinity Grammar has developed a proud tradition in rowing, supported by excellent resources, strong student participation, and a highly engaged parent community. The Director of Rowing builds on this legacy by fostering a positive and aspirational team environment that balances participation and performance. This position requires a dynamic and organised leader who can manage the day-to-day logistics of training and competition while also driving long-term program growth. The role involves regular early mornings, weekend commitments, and out-of-hours work, balanced by a flexible work schedule in consultation with the Director of Sport.

## Key Responsibilities and Duties

### **Team Leadership**

- To exercise effective team leadership that underpins the organisational structure of the School
- Continue to develop a rowing program ethos that is congruent with the tradition and direction of the School
- Coordinate students, staff, parents, and coaches to ensure Trinity Grammar School crews reach their rowing performance potential
- Maintain cooperation with Rowing Victoria
- Ensure a balance between enjoyment and performance amongst all rowing crews, aligned to the School's Personal Best Wellbeing Program
- Lead and maintain a positive relationship with the rowing parent's committee (Cowey Club)



#### **Administration & Program Management**

- Work collaboratively with the Director of Business and the People & Culture team for the recruitment, employment and induction of rowing coaching staff
- Liaise with People & Culture and Payroll regarding the employment and remuneration of all rowing coaches
- Oversee the Rowing Coordinator/s to ensure they perform their duties and coordinate the maintenance of the rowing equipment
- Take responsibility for the mentoring of coaches and assisting in their professional development
- Continually plan and review the financial management of the program with the Director of Business and Finance Team to identify means of maximising the effectiveness of the program
- Manage the purchase and security of all school rowing equipment and make recommendations to the Director of Business on budgetary matters.
- Plan and manage all aspects of rowing camps ensuring all logistical, risk and financial obligations are met
- Coordinate the logistics of trainings, regattas, and camps (including transport, Risk assessment, work health and safety, food and equipment)
- Oversee the selection of crews and transparent criteria for crew and seat selection processes
- Determine specific training goals and performance levels for each section of the program
- Encourage participation beyond schools, including high performance pathways and club rowing
- Communicate clearly with all sections of the rowing community (weekly updates)
- Ensure that crews have opportunity to participate in a range of regattas throughout the season
- Advise on other matters relating to competition including injury prevention and management, nutrition and recovery
- Determine and oversee an appropriate winter training program
- Contribute to the planning and organisation of rowing events and associated fundraising
- Assist the Director of Sport with the strategic planning of the program within the overall sporting framework
- To organise coaching and training sessions for all age groups
- To oversee the organisation of Rowing in all regattas, inter school activities and tours
- To nominate senior students for School Colours
- To provide a TIC Report for the School Mitre each year, as well as the collation, proofing and submission of all articles and photographs relevant to the particular sport
- To act as the School representative on the relevant external Committees for Rowing and attend all relevant meetings



#### Risk Management & OH&S

- Maintain safety procedures, risk assessment and policies for all personnel involved in the sport
- Attend all water sessions and establish, monitor and maintain safety standards relevant to the sport
- Take reasonable care of and cooperate with actions taken to protect the health and safety of self and others
- Report all accidents, incidents and hazards as soon as is practicable via the schools procedures
- Read, understand and adhere to all Trinity Grammars Risk, OH&S and Child Safety guidelines and policies

## **General Responsibilities**

- To ensure that appropriate supervision is provided at all times during trainings and events, and to arrange supervision in the event of a coach being unavailable
- To provide new parents and students with appropriate program and induction information about the sport
- To take initiatives communicating with parents
- To advise the Deputy Principal, Head of Senior School and Director of Sport on all significant matters
- To update the School Community on regatta results
- Act as an excellent role model for students, colleagues, and parents; always representing the School in a positive and professional manner
- Attend School and Senior staff meetings as required
- Demonstrate a commitment to one's own professional learning, including undertaking regular professional development activities in relation to the requirements of this role
