THE CROSS RIVER RAIL PROJECT

The Cross River Rail Delivery Authority is building a new 10.2km rail line that includes 5.9km of twin tunnels running under the Brisbane River and CBD; with four new underground stations at Boggo Road, Woolloongabba, Albert Street and Roma Street.

Once complete, it will provide trains with a much-needed alternative rail path through the core of the current SEQ Rail network, unlocking a bottleneck and allowing more trains to run more often across the whole of South East Queensland.

The Cross River Rail Delivery Authority is also delivering multiple supporting projects and activities in conjunction with Department of Transport and Main Road. These include accessibility rebuilds for eight surface stations, construction of three new stations on the Gold Coast; upgrades for stabling yards; track works and surface rail enhancements; and the introduction of a new ETCS digital signalling system.

ROLE OVERVIEW

The Extended Possessions Manager is responsible for the program management and planning of extended track possessions (commonly referred to as extended track closures, shutdowns or occupations) across all Cross River Rail work packages. The team works with delivery contractors (PPP, Alliance and D&C) and key stakeholders (including Transport and Main Roads and Queensland Rail) to ensure delivery staging is logical, achievable within operational and customer constraints and aligned with project priorities.

Due to the significant pipeline of SEQ rail projects underway, this role is required to work and interface with Transport and Main Roads rail projects to ensure CRR delivery is integrated and considers the cumulative rail network impacts and requirements.

This position reports to the Senior Possessions and Delivery Sequencing Manager and forms part of the Customer and Network Integration team.

KEY RESPONSIBILITIES

- Chair multiple multi-agency working groups to facilitate the development and endorsement of extended possession applications and monitoring of readiness for upcoming extended possessions.
- Support contractors in application for extended possessions including justification of track access based on construction requirements.
- Ensure robust governance and informed decision-making by applying established frameworks, maintaining transparency, and supporting stakeholders to reach timely and aligned outcomes.
- Coordinate state agencies to identify opportunities to optimise extended possessions, aligned to low demand periods on the public transport network.
- Identify network-wide possession regimes that consider current and future rail construction project activities.
- Monitor any changes / risks in the construction schedule that may affect planned extended possessions, including facilitating the development of mitigations and contingency planning where required.
- Develop materials (feasibility assessments, options analyses, readiness assurance documentation and associated checks) for governance review and approval
- Provide structured information, administer and present at the Delivery Sequencing Steering Committee to support decisions on extended possessions.
- Work with key stakeholders across multiple disciplinary areas to inform them on all changes to the extended possession program and provide up to date information.
- Report progress and escalate risks to the Senior Possessions and Delivery Sequencing Manager and give advice on solutions and mitigation measures.
- Manage key processes, documents and tools, ensuring compliance with key project requirements.
- Lead the Extended Possession's team in the delivery of their responsibilities including setting and supporting completion of KPIs and development plans.
- Work in accordance with the Delivery Authority policies, procedures and safety requirements and demonstrate alignment with our values and behaviours.
