# **POSITION PURPOSE**

Genazzano Early Learning Centre (ELC) is a co-educational 3 and 4 year old program. The program blends the rich traditions of the Reggio Emilia Approach through listening to children, providing provocations and a breadth of learning opportunities – the 100 languages of the child. Collaborative research and inquiry based learning best suits this approach and gives sense and meaning to the children's learning.

At Genazzano, we value and build strong partnerships with families to support each other in the journey of developing responsible, contributing future members of our community within & beyond the Genazzano gates. Our teaching style recognizes young children best develop where there are predictable routines, consistency of approaches and expectations, and where strong relationships are formed with teaching staff and peers.

The primary purpose of the ELC Co-Educator is to assist the Lead Teacher to deliver and promote learning within the program.

#### **POSITION OBJECTIVES**

- Assist in building strong relationships through positive and supportive communication with children, families and staff with the aim of maintaining a consistent positive tone in the ELC
- Inform the Director and/or Lead Teacher if concerned that Education and Care Services National Regulations and Education and Care Services National Law Act 2010 are not being met.
- Aim for an early resolution to any issues of conflict, by ensuring actions restorative and professional
- To maintain confidentiality on all issues relating to children, families and staff.
- Support the vision and ethos of the College

# **RESPONSIBILITIES AND DUTIES**

- Work as part of the ELC team, supporting the Lead Teacher and Director by carrying out the stated aims and philosophy of the Early Learning Centre.
- Support the Lead Teacher in the planning and implementation of a high quality Early Childhood Curriculum
- Support the development of opportunities which allow the children to experience Christian celebrations within the Catholic tradition
- Be a supportive role model for the children
- Interact with all children in a positive and caring manner
- Inform the Lead Teacher of any family feedback, concerns or general communication as soon as possible
- Assist with the supervision of the children during planned activities and when attending Specialist classes
- Assist in the implementation all daily routines, planning and set up requirements
- Assist in preparation of materials and compilation of portfolios
- Execution of daily housekeeping tasks in accordance with College expectations and in consultation with the Lead Teacher, including the responsibility of cleaning during the day, as required
- Attend and actively participate in staff meetings and professional development activities as required in order to assist in the effective management and programming for the ELC
- Display flexibility to work as a cooperative and professional team member sharing responsibilities and duties with different Lead Teachers
- Follow all legislative requirements of an Early Learning Centre
- Adhere to all College policies and procedures as detailed on Genconnect, the Staff Handbook and communicated electronically.

### **ACCOUNTABILITY AND EXTENT OF AUTHORITY**

- The ELC Co-educator is accountable to the ELC Director
- For implementation of Child Safe Standards, this position is accountable to the Deputy Principal Child Safe Officer
- The position must ensure that it operates in accordance with the specific objectives, policies
  and strategies determined for the effective management of the College's resources and ensure
  decisions made by the position are subject to review by the ELC Director.

- Possess a recognised Certificate III or be working towards a Diploma in Early Childhood Education and Care (or equivalent as recognised by ACECQA)
- An understanding of the Reggio Emilia approach and demonstrate the ability to support the incorporation of this approach into the curriculum
- Demonstrated ability to support and implement a quality curriculum
- Demonstrated ability to implement the NQF, NQS and EYLF
- Demonstrated experience and commitment towards Early Childhood education
- Innovation and flexibility in delivering to individual children within their learning environments
- Well organized, and strong time management skills
- Ability to multi-task and use initiative to problem solve
- Collaborative, flexible team player
- Accepting of all families, children and staff members
