THE ROLE: The Kids 4 Life program works directly with children 0-5 years and their families to increase their safety and wellbeing. The purpose of this role is to coordinate and deliver Kids 4 Life program activities in line with contract specifications, funding body targets and outcomes and to collaborate with other services to meet the needs of children and their families experiencing vulnerabilities, such as domestic and family violence, mental health needs, drug and/or alcohol needs, and social / economic disadvantage.

- Design, resource and deliver three weekly supported playgroups aimed at assisting families with children 0-5 years, including Aboriginal Torres Strait Islander and CALD families
- Effectively engage and support targeted families to build their capacity to meet the needs of the children in their care, through an inclusive and strengths-based approach
- Provide families with relevant information, assisted referrals and home visits, to support their connection to other support services
- Develop and coordinate Kids 4 Life Community Capacity Building initiatives in partnership with local service providers, YWCA Early Childhood programs and in line with funding body targets and outcomes

- Manage the Kids 4 Life program budget and following YWCA financial procedures
- Manage all report writing and evaluation tasks relating to the program, including reporting to funding bodies and using the YWCA Results Based Accountability Framework (RBA)
- Ensure all program activities are delivered in line with YWCA operational requirements, policies and procedures
- Undertake other tasks as assigned by the manager
