Role Purpose and Scope:

The purpose of the Pilot/Marine Officer's role is to:

- Provide safe and professional pilotage to all those ships requiring or requesting pilotage.
- Act as Duty Pilot, plan and allocate berthage, pilots, staff and tugs/launches to planned movements.
- Take charge of any of the port's floating plant.
- Act as a Tug Master (performing the normal functions of Tug Master), or in a temporary position as Launch Master, where suitably trained to do so.

Ensures that currency, medical standards and CPE requirements are met. Mentors and trains junior pilots.

Duty Pilot	 Undertakes ship planning and cost-effective allocation of berthage, pilots, staff and tugs/launches. Ensures changes are promulgated without delay and staff informed accordingly. Responsibility is taken to ensure 24 hour coverage in the Duty Pilot's role. 	
Towage & Launch and floating plant	 Retains currency on floating plant on which training has been provided. Manoeuvring of CentrePort's plant is subject to good seamanship and is directed in a safe and controlled manner at all times. All statutory and regulatory requirements are met. Assists with docking and surveys when required. 	
Customer Relations (internal and external)	 Provides professional service and ongoing support to customers, acknowledging the high profile and importance of Marine Services. Asks questions to identify customer needs, explores options, and provides tailored service solutions that are cost effective and appropriate to the client. Looks for ways to continuously improve results and outcomes to increase customer satisfaction. 	
Safety Equipment	 Ensures that all safety equipment is in position, in working condition and in currency (includes any port LSA). Promptly reports defective equipment. 	
Other	 Assists with SOP development, SSM Manuals and reviews. Assists with examination of candidates for PEC examinations. Carry out other duties within capability as directed.
