- Work closely alongside other members of the Allied Health team to provide a holistic multidisciplinary service
- Provide services within the requirements of the National Disability Insurance Scheme
- Able to work independently and is required to exercise independent judgement on routine matters. May require professional supervision when performing novel, complex, or critical tasks.
- Demonstrate a commitment to professional development and contribute to workplace education through seminars, lectures or inservices
- Contribute to the sustainable provision of Allied Health Services by achieving service delivery targets as set by your Manager on a bi-annual basis
- Is actively involved in quality improvement activities or research
- Contributes to the evaluation and analysis of guidelines, policies and procedures applicable to professional work and may be required to contribute to the supervision of discipline specific students.
- Develop collaborative partnerships within the local disability sector
