The Pre-Service Teacher Tutor (PST-Tutor) role strives to support students in seeking continuous improvement and fostering a culture of personal excellence where students are aspirational and monitor and goal set for individual improvement. The PST-Tutor works in partnership with staff and students to provide additional opportunities for students to seek assistance and support in their knowledge and skill development, and to promote a culture of high standards of academic rigour and behaviour.

Duties

- Attendance at the College's Home Study Club on Tuesday and/or Thursday afternoons.
- Providing assistance and support on a one-on-one basis to students, as requested, during the after-school Home Study Club.
- Planning and running tutorial groups covering specific content or topics, in an area of specialty, during the after-school Home Study Club.
- Maintaining familiarity and knowledge of content being covered in classes and subject areas, in areas of specialty, to ensure support given is current and applicable.
- Preparing resources, as may be identified, to assist students one-on-one or in tutor groups.
- Promoting the availability of tutor groups and support at the Home Study Club.
- Keeping a record of student attendance at Home Study Club and in tutorial groups.
- Duty of Care and Child Safety responsibilities.

Selection Criteria

- A commitment to Catholic education and the Marist Charism of the College.
- A commitment to Child Safety and experience in creating a child safe culture.
- Highly developed written and verbal communication skills
- Highly developed interpersonal skills and the ability to relate to and engage with people at all levels of an organisation through collaboration and clear communication.
- Highly developed organisational skills.
- Currently completing second- or third-year studies in a tertiary teacher training qualification

Child Safety
