## **Primary Objective:**

In Great Company is powered by Feros Care and Aspire4Life and is a volunteer program designed to connect people in need of support and social connection with caring, friendly, and enthusiastic volunteers.

Part of the portfolio of In Great Company is this new role which supports the work of the residential villages of Wommin Bay, Bangalow, and Byron Bay, which house aged clients of Feros Care.

This volunteer role particularly supports the Covid-19 response to visitors of residents, assisting with safety protools, and asking screening questions prior to those visitors coming on site.

## **Key Responsibilities:**

- Support the Residential Team to provide access to families in the three Feros Care Residential Villages; Wommin Bay, Bangalow and Byron Bay.
- · Assist in manning entrances and assessing visitors to the sites
- Ensure visitors follow hygiene protocols; e.g. use of santiser
- Asking screening questions and complete a questionnaire with visitors prior to entering the facilities
- Taking and accessing a visitor's body temperature
- · Escorting visitors to the client's rooms
- Receiving or directing deliveries on site to the appropriate recipient or manager
- Bring your best positive and engaging self, to lift the spirits of those visiting, and offer reassurance
- Embodies a friendly and cheerful volunteer spirit
- Tech-savvy and able to use a communication device on site
- Willing to go the extra mile to ensure those most at risk in our community are safe, and can still see their families
- Supportive of the wider clinical team, and happy to bring your best self as their right arm
- Operates with integrity, open-mindedness and respect, ensuring the privacy, confidentiality and dignity of our clients is maintained at all times
