## **Position Summary**

The purpose of this role is to provide high quality and evidence-based services that support children's communication skills. As a Speech Pathologist, you will assess, diagnose, and provide evidence-based supports to children in our service centres and in school programs.

This role is responsible for working closely with children and families to assess communication skills, form treatment plans, deliver services, and review progress. This role works closely with clients and families; well as working alongside other professionals and support teams to deliver excellent clinical services, customer, and financial outcomes to support the organisation's financial sustainability. Speech Pathologists provide services to children and families in school programs, as well as working in our service centres. Speech Pathologists engage in lifelong learning and reflective practice by setting clinical and professional goals and engaging in different types of learning such as self-directed learning, attendance at workshops, clinical supervision and mentoring to ensure up to date knowledge of Speech Pathology Practice.

This role requires regular travel to Learning Links clinics and local schools to deliver programs.

## **Responsibilities and Duties**

#### Program delivery

- Conduct assessments with children & families to identify communication difficulties and disorders.
- Develop customised treatment plans for children in collaboration with families, setting clear goals and objectives and regularly monitoring progress.
- Provide evidence-based interventions to children to support their communication skills.
- Collaborate with parents/caregivers, school communities and other professionals to provide education and guidance on strategies and techniques to support children's speech and language development at home and in education settings.
