## Responsibilities

The Health and Safety Superintendent is responsible for assisting the Director Health and Safety to develop and implement health and safety management and compliance systems at Pilbara Ports, driving a strong health and safety culture. The Health and Safety Superintendent is also responsible for supervision and leadership of the Port Hedland Health and Safety team, ensuring key deliverables are met.

The Health and Safety Superintendent reports to the Director Health and Safety.

Tertiary qualifications in a related discipline.

- Ability to make effective decisions and analyse problems and identify solutions.

### **Work Related Requirements:**

- Significant experience in a work health and safety role within a marine, mining or heavy industrial environment.
- Proven ability to develop and implement safety processes as well as identify and implement improvements to enhance operations.
- Accomplished at developing and maintaining high performing teams.
- Well-developed written and verbal communication skills including the ability to achieve outcomes through liaison and negotiation.



- Demonstrated ability to deal with competing priorities whilst monitoring and promoting compliance and improvement.
- Sound understanding and ability to operationalise legislation, standards and procedures.

Sound computing skills, as well as the ability to gain a Maritime Security Identification Card, and WA Driver's License are prerequisites for positions with Pilbara Ports.
