- Prepare, oversee and review Code Amendments whether Council, State or proponent initiated to enable Council's expectations for new development to be met.
- To perform the role as executive officer on Council's internal Major Urban Renewal & Land Division working group and Council's Technical working Group.
- Assess opportunities and constraints for future development within the City of Charles Sturt and provide expert advice and input to strategies that promote sustainable development from a planning policy perspective.
- Pro-actively establish and maintain partnerships, relationships and strategic alliances with key Local Government, development industry and State Government stakeholders.
- Manage Council's heritage and significant tree grant applications.

- Represent the City Planning & Sustainability portfolio on matters relating to urban development policy and planning.
- Positively contribute to our constructive culture by living our values which guide decision making and delivery of outcomes for our community.
